D. How long will we keep your data? The length of time that your personal data may be kept will vary depending on the service you sign up to. In all cases, your data will be kept for the duration of the contract. Once the contract has ended, we will keep your data locked during the obligatory limitation period that may apply as a result of data processing, and/or for the applicable legal time period, for purposes relating to possible obligations resulting from the processing of your data. During this time, your data will remain available to the relevant authorities.

E. Legal basis for the processing of your data:

a. The legitimacy of the processing of your data for making a booking is based on the implementation of a contract between the parties.

II. Who will your data be shared with?

III Exercise of rights:

You have the right to request confirmation about whether or not we are processing personal information that concerns you. As an interested party, you have the right to access your personal data, request corrections to inaccurate data or, where appropriate, request its deletion when, amongst other reasons, it is no longer required for the purposes for which it was originally collected. In certain circumstances, you may request limitations to the processing of your data, in which case it will only be kept in order to manage or defend possible claims. In certain circumstances, depending on your particular situation, you may object to the processing of your data. In this case, we will stop processing your data, except for overriding, legitimate reasons, or to manage or defend possible claims. In cases where processing of your data requires your consent, you may withdraw your consent at any time. In cases where it is legally applicable, you have the right to the transfer of your data, which implies the right to receive the personal data we are processing which relates to you and store it on your own device. This right also entitles you to ask us to communicate your data to another person for their use. Additionally, if you believe there is a problem or incident relating to the processing of your data, you can contact the company via the contact address contained in this document. You have the right at any time to file a claim with the relevant authorities relating to protection of personal data, which in the case of Spain is the Spanish Data Protection Agency.
